4) Treasurer's Report

**Paul Bratulin** 

P. Bratulin reported that CCPRO received another fraud alert. Someone tried to make two purchases of \$300 and \$465 through an online business. CCPRO advised that the purchases were fraudulent; the charges were reversed and the money was returned. It appears to be safe to resume moving money out of the Wells Fargo account which is slated to be closed down following the phishing attack last October. P. Bratulin plans to work on those transfers in March, emptying out both Wells Fargo and PayPal accounts. There is a total \$79,505 on all accounts. It was noted, however, that CCPRO members must still pay into PayPal when they apply for CCPRO awards, so the PayPal account must remain open.

### 5. 2019 Conference updates

### a. Registration update

There is a need to confirm that those who register for the conference as CCPRO members are, indeed, members. A.Krueger will forward the latest membership list. We will need to send emails to anyone who has registered as a member but is not on the membership list. In terms of registration itself, the biggest concern is the block of hotel rooms. CCPRO's block of rooms is reserved until March 11. We are at 112 rooms and are contracted for 160 rooms. However, A.Krueger noted that sponsors have not yet registered and that many CCPRO members typically wait until the deadline approaches before registering. Another reminder message will be sent emphasizing the March 11 cutoff.

### b. Program

A. Krueger reported that the conference program looks good and has been sent to the league for posting on the website. It will also be posted on CCPRO's website. The program includes a lot of good content for conference attendees.

### c. CCPRO Awards

D. Ysais reported that awards are going very well. After an "avalanche" of entries in mid-February, the count now stands at 343 entries. The quality of entries is also very high. It was a good idea to extend the deadline. An email will be sent to colleges that have won an award as an incentive for them to attend the conference. As a side note, for the first time, all nine Los Angeles-based colleges are now members of CCPRO.
